

***Krakow – my home?* Competition Terms & Conditions**

1.

The Photography Competition is organised by the Multicultural Krakow Association (Stowarzyszenie Wielokulturowy Kraków,) registered in the Register of Associations established by the District Court for Kraków-Śródmieście, 11th Commercial Division of the National Court Register with the number: 0000746139; REGON number: 38111027100000; NIP number: 6772437214. The Competition is part of the project *Krakow – my home* financed by the Municipality of Krakow.

2.

The Competition can only be participated by natural persons with full legal capacity, currently residing in the Republic of Poland. The Competition is addressed to all citizens of Krakow, foreigners in particular.

3.

Minors can only take part in the Competition with the consent of their parents or legal guardians.

4.

The Competition is not a game of chance, a raffle, nor a promotional lottery as defined by Article 2(1) of the Act on Gambling Games of November 19, 2009 (Journal of Items of 2009, No. 201, item 1540 as amended) and thus is not subject to the regulations of the Act nor the executory orders that refer to it.

II. Conditions of participation

1.

The photos submitted to the Photography Competition must be original work of the Entrants, remaining unpublished (including the Internet) until the end of the Competition (December 28, 2020.) All photos must refer to the main theme of the Competition, that is *Krakow – my home*.

2.

Each Entrant can submit 1 to 3 photos (submitting several images at once by one Entrant will be considered one Entry [photo coverage].) Submitted photos shall include descriptions in Polish or English, explaining their reference to the theme of the Competition. The length of the descriptions must not exceed 1500 characters.

3.

All photos must be entered through the online application form at the website of the Association. If an Entrant does not have access to a Google account, the application form can be downloaded and further sent, along with the images, to the following e-mail address: kontakt@wielokulturowykrakow.pl. The images must be in PNG format. The longest dimension of the image shall be at least 1920 pixels. The maximum file size for one image is 10 MB.

Only the photos entered between December 13, 2020, 21:00 hours and December 28, 2020, 23:59 hours will participate in the Competition. All the Entries submitted before or after the designated period will not be officially considered.

4.

The participation in the Competition is free and voluntary. All entered work must be originally prepared by the Entrant submitting the photographs.

5.

The Entrant is obliged to have obtained permission from any people featured in the submitted photographs to reproduce their physical likeness within the framework of the Competition, including the release of their personal image on the websites and social media pages and profiles of the Organiser (Facebook, Instagram, Twitter,) as well as in any other media that should publish any information regarding the *Photography Competition #krakowmojdom*.

6.

By submitting a photograph to the Competition, the Entrant states they are indeed authorised to publish the personal image of any people present in the photos and that they are the full copyright owner of these photos.

7.

By publishing the photo, the Entrant grants the Organiser a non-exclusive, royalty-free licence to use the image without any temporal or territorial restrictions regarding further publication of the photo through public performance, exhibition, displaying, reproduction, broadcasting and re-emission, as well as making the photograph publicly available in a way that enables the access to it to anyone in any desired place and time.

By sending the application form, the Entrant hereby accepts the Terms & Conditions of the Competition and any related requirements for the participation.

III. Choice of winners and announcement of results

1.

The photographs will be judged by the Competition Committee comprised of judges nominated by the Organiser.

2.

The winners will be chosen by the Competition Committee out of all the Entries.

3.

The judgement of the Competition Committee will be based on the correspondence of the photos with the aim and theme of the Competition, their creativity, artistic values and technical aspects.

4.

The decisions of the Competition Committee are final.

5.

The results will be announced on December 30, by 23:59 hours, on the Facebook page and Instagram profile of *Multicultural Krakow*.

6.

The Entrant agrees to the publication of their work at www.wielokulturowykrakow.pl, in social networks: Facebook, Instagram, Twitter, and in any other media that should publish any information regarding the *Photography Competition #krakowmojdom*.

IV. Prizes

1.

The winners will receive the following Prizes:

2.

1st place: set of Prizes worth 400 PLN; publication of photos on the Instagram and Facebook pages of the Multicultural Krakow Association,

3.

2nd place: set of Prizes worth 300 PLN; publication of photos on the Instagram and Facebook pages of the Multicultural Krakow Association,

4.

3rd place: set of Prizes worth 200 PLN; publication of photos on the Instagram and Facebook pages of the Multicultural Krakow Association,

honourable mention: set of Prizes worth 100 PLN; publication of photos on the Instagram and Facebook pages of the Multicultural Krakow Association.

5.

The receipt of the Prizes will be scheduled within 14 days following the verdict of the jury in a place specified by the Organiser of the Competition.

6.

The Organisers reserve the right to leave the Competition unresolved.

V. Responsibilities, final provisions

1.

The Organisers shall not be liable for not receiving or receiving the application form from the Entrant with delay due to reasons beyond the Entrant's control, particularly due to reasons attributable to the server administration.

2.

The Organisers shall not be liable for the Entrants' non-compliance with the Terms & Conditions, particularly if the theme of the photo should violate the third-party rights, the standards of decency, or any other general legal provisions in any way.

3.

The Prizes in the Competition are non-transferable to any other Prize or its equivalent in cash.

4.

By taking part in the Competition, the Entrant agrees to their personal data being processed for the purposes related to the Competition. Providing access to the personal data for the purposes related to the Competition is a requirement for any Prize to be granted.
